Public Notice

Public notice is hereby given that the 2021 Assessment Roll for the Town of Niverville has been delivered to the Town Office at 329 Bronstone Drive and is open for public inspection during regular office hours. Applications for revision may be made in accordance with sections 42 and 43 of The Municipal Assessment Act.

Under The Municipal Assessment Act S.M. 1989-90, c.24-Cap.M226

APPLICATION FOR REVISION

42(1) A person in whose name property has been assessed, a mortgagee in possession of property under section 114(1) of The Real Property Act, an occupier of premises who is required under the terms of a lease to pay the taxes on the property, or the assessor may make application for the revision of an assessment roll with respect to

- a) liability to taxation;
- b) amount of an assessed value;
- c) classification of property; or
- d) a refusal by an assessor to amend the assessment roll under subsection 13(2).

APPLICATION REQUIREMENTS

43(1) An application for revision must

- a) be made in writing;
- b) set out the roll number and legal description of the assessable property for which a revision is sought;
- c) state the grounds on which the application is based; and
- d) be filed by
 - (i) delivering it or causing it to be delivered to the office indicated in the public notice given under section 41(2), or
 - (ii) serving it upon the secretary, at least 15 days before the scheduled sitting date of the board as indicated in the public notice.

The Board of Revision will sit on October 20th, 2020 at 7:00 p.m. to hear applications. Location to be confirmed at a later date.

The final date on which applications must be received by the Secretary of the Board is **October 5, 2020** by 5pm. Applications may be either mailed to the address noted below or delivered to the Town Office at 329 Bronstone Drive, Niverville. Please ensure application(s) is (are) submitted in accordance with Section 43(1) noted above.

A reminder that **September 30th, 2020 5:00 p.m.** is the deadline for **property tax, waste collection, and utility payments** in the Town of Niverville.

Early payments are encouraged as procedures for payments may change due to COVID-19.

Please consider using one of the following contactless options for submitting your payment:

Mail: Include bottom portion of tax statement(s)/ utility account number(s) with payment to: Town of Niverville, Box 267, Niverville, Manitoba R0A 1E0.

Internet banking: Available through most financial institutions. To ensure electronic payments will not be subject to a late penalty, please allow at least 3 business days for bank processing.

Drop box: located at the front of the Town Office at 329 Bronstone Drive. The drop box is checked Monday to Friday and at 5 p.m. on the due date. Payments dropped off after 5 p.m. on September 30, 2020 will be considered late and will be subject to a penalty. Please make cheque or money order payable to the Town of Niverville.

**NOTE: Statements currently showing arrears will have additional penalties - please call the Town Office or log-in to your eServices account for a current balance. Note that penalties are posted on the first of each month.*

Please note that there is no exact route or timeline.

Occasionally during sewer cleaning, air pressure builds in the sewer line causing water to splash out of toilets, sinks and drains. Please take the following precautions to prevent water damage in your home:

Close lids and cover toilet bowls when not in use.

Insert drain plugs in all sinks and bathtubs when not in use.

Remove all floor mats in bathrooms.

Place an old towel around base of toilets.

Cover all basement floor drains.

Sewer cleaning on rare occasions may leave an odor in the home. If so, please run some water down all sink and bathtub drains, flush toilets, pour a pail of water into each basement floor drain and open your windows. After a short time the odor should disappear.

- Wood
- Concrete
- E-waste
- Tires
- Propane tanks
- Paint
- CFL's and fluorescent light bulbs
- Used oil & oil filters
- Appliances: \$20/per fridge or freezers, all other appliances no charge
