 - That names and phone numbers of individuals who may be C. contacted should an emergency arise and it becomes necessary to access Main Street be provided to the Town;
 - d. That a map be provided to the Town's Operations Manager outlining the detour route, including locations for detour signs and

- clearly indicating alternative routes; and
- e. That the Niverville Fair Committee ensure that the barricades to Main Street are staffed when equipment and supplies are being moved in and out.
- 2. That the Town of Niverville hereby serves notice to the Province of Manitoba that the Town through its insurance broker, will continue the practice of saving harmless the Province of Manitoba from and against all claims, liabilities, losses, or suits which may arise from vehicles using the designated detour routes which will result from the closing of Main Street from June 5th, 2025 to June 8th, 2025 within the Town of Niverville.
